CULTURE & CONTEXT

The cultural context of psychoanalysis includes both the context of the patient and the context of the analyst. For both, context is multilayered and includes microcultures such as theoretical perspective and political affiliation, as well as larger cultures such as religion, sexual orientation, ethnicity, and class.

How the individual views her/himself, and is viewed by others, depends on a complex interaction between relatively stable psychological structures and this multilayered cultural context. What have we learned from psychoanalysis about the nature of this interaction? What are the relationships between flexibility or adaptability, on the one hand, and false self or as-if personality on the other? What allows some people to seemingly more easily move among cultures while others cannot leave their culture without a deep sense of loss, alienation and disorganization? How does the analyst's cultural context affect his/her work? These are the kinds of questions we would like to address.
