UNIQUE FAMILY CONFIGURATIONS, NEGLECTED FAMILY TIES: Psychoanalytic Perspectives

Psychoanalysis, from its inception, has primarily concerned itself with the vicissitudes of the parent-child triad in understanding personality development. In recent years the psychoanalytic literature has also given increased attention to the mother-child dyad. Far less attention, by comparison, has been given to the other ties within the family. This conference offers the opportunity to look more closely at the potential impact of other family ties on the developing individual. The contributors, individually and as a group, address themselves to such lesser-examined relationships as grandparents and siblings, neglected aspects of the parenting experience, and to the psychoanalytic issues involved in such unique family configurations as single parenthood by choice.

The PSYCHOANALYTIC SOCIETY also sponsors:

The Continuing Education Program, offering seminars and workshops to mental health professionals and to individuals with allied interests.
