Topics include: patient selection; distinctions between psychoanalysis and psychoanalytic psychotherapy; ego autonomy, superego maturity, and other structural considerations; the nature of the working alliance, characterological transference, floating transference, the transference neurosis, and countertransference; regression; defense; resistance; dreams; confrontation, clarification, and the accuracy, depth, choice and timing of interpretation; and, working-through and termination.
