Scholar's Grant Application Requirements
Due Date: **January 12, 2026**

The Scholar's Grants are designed to jump-start promising academic, clinical, creative, or research projects carried out by Members in good standing of the Psychoanalytic Society, or by Candidates in the NYU Postdoctoral Program who have joined the Society as Candidate-Members.

- Individual Grants carry stipends of **\$2,000**.
- Group Grants carry stipends of **\$3,000**.
Groups are limited to 2 individuals at \$1,500 each.
Contributions of others will be acknowledged publicly if you so desire.
- Patrick Lane Candidate Grant is for **\$1,500**.

Applications for Individual and Group Grants will be accepted from any current Member in good standing of the Psychoanalytic Society. Applicant must have registered and paid dues in full before the application will be accepted. **Patrick Lane Candidate Grant** applications will be accepted from any current candidate in good standing in the NYU Postdoctoral Program who has registered as a Candidate-Member in the Psychoanalytic Society. Contact our administrator at thepsychsociety@gmail.com to join or renew membership. There is a lifetime limit of two grant awards per individual per grant category.

Please Note:

1. Recipients of the Scholar's Grant must be prepared to submit an interim progress report in January following the Grant award and make a presentation of the project's progress at a Scholar's Grant Brunch approximately 18 months following receipt of the award.
2. The Psychoanalytic Society of the Postdoctoral Program must be credited as a funding source IN ALL FORMS OF PRESENTATION AND ADVERTISING to professional and public audiences.
